- 2. THAT this By-law shall take effect upon adoption by Council of the Township of Alfred and Plantagenet.

Route 14 between Conc. 6 and 7

Conc. 6 from Route 14 to Plantagenet Station Station Rd from Conc. 6 extension to Nation River

Pitch off Rd from CPR to Conc. 7

Conc. 7 from Pitch off Rd to Boundary Rd

Boundary Rd to Conc. 8

Conc. 8, Boundary to Caledonia Spring Division Rd from Conc. 6 to Wendover

road allowance between lot 12-13 from Cty rd #24 to Conc.4

Conc 4 to Peladeau

Conc 2 from road allowance to Cty Rd 15 Conc 5 from Bdry Rd to Cty Rd # 15

Cone 5 from Pitch off to Cty Rd 17

road allowance between lot 2-3 from Cty rd 17 to conc 7

Expansion: Boundary Rd Conc 7 to Conc 2

> Lake George Rd from Bdry rd to Conc 2 Conc 2 from Lake George rd to Route 21 Conc 2 from Boundary to Ctv rd 15

Right way between lot from CPR to conc.7 (Mr Leduc)

Conc 7 from Cty rd 9 to Route 14 Mill st from conc 7 to Village Curran Route 16 from Conc 7 to Conc 3

Conc 3 between Route 16 and Route 25 Route 25 from Conc 3 to Principale st Conc 2 from Route 25 to Division Rd

Also the by-law should include a right to circulate within the Village of Wendover, Lefaivre, Plantagenet, Curran and Alfred to circulate from your place of residence to access the ATV trail, place of business (gasoline, restaurant, motel) with a speed limit of 20 km/h within the Villages

These new expansion would give us access to the Village of Wendover, and Lefaivre and Alfred and Curran

Already some of the local businesses are beneficiating from this recreo touristic sport. With the recent expansion in Nation Twp, our Club as grown and we now have over 300 members travelling through our trails. We also form a new Club in the Winchester area which will officially open on the 04 Oct 2008, this Club will give us access much further west.

We are still attempting to expand east, but have encounter some difficulties.
